**NOTIFICATION**

In Pursuance of the Law and Justice Commission of Pakistan's (LJCP) Notification bearing F.No.14(199)/UDR-Committees/2025/AJDF/LJCP dated 18.02.2025 and upon nomination of their representatives by the Ministry of Planning, Development and Special Initiatives (Governance Section), Islamabad, Office of Chief Commissioner, ICT and the CDA, the Hon'ble Chief Justice of this Court has been pleased to constitute **Development Committees** at Islamabad High Court, Islamabad, and the District Judiciary-ICT (East and West) to scrutinize the demand and execution of projects from Judicial Development Fund (JDF) Windows. The Composition and TORs are as under: -

**Provincial Development Committee (PDC)**

- i. Registrar Islamabad High Court (Chairman)
- ii. Chief (Governance), Ministry of Planning, Development and Special Initiatives (Governance Section), Islamabad.
- iii. Director General (P&D), Islamabad High Court, Islamabad
- iv. District & Sessions Judge (concerned).

2. **The TORs of the Committee shall be as follows: -**

- Evaluate project proposals submitted by the District Development Committee for their financial requirements, necessity, and alignment with eligible expenditure criteria.
- Ensure that there is no duplication of funding sources, including but not limited to allocations from the Annual Development Program (ADP), Public Sector Development Program (PSDP), Donor funded etc.
- Advise on the feasibility of projects and recommend the release or allocation of funds from the LJCP based on comprehensive assessments.
- Conduct periodic reviews of project implementation and progress.
- Offer expert advice and support to the District Development Committee to ensure compliance with established guidelines.
- Address challenges and recommend corrective measures where necessary to enhance project efficiency and effectiveness.

**District Development Committee (DDC)**

- i. District & Sessions Judge (concerned) as Chairman,
- ii. Deputy Director (Dev.), Office of Chief Commissioner, ICT, and
- iii. Dy. Director Works Division-II, Works and Services Department, Capital Development Authority (CDA).

**The TORs of the committee shall be as follows: -**

- Ensure that project demands comply with the eligible expenditure guidelines under the Judicial Development Fund (JDF) and Under-Development Regions (UDR) windows.
- Prepare project proposal clearly stating its objectives, scope, implementation, plan, expected outcomes and cost estimates.
- Oversee the execution of the project to ensure that it strictly adheres to the approved scope and plan.
- Continuously monitor both the physical and financial progress of the project to identify and address any bottlenecks in a timely manner.
- Resolve issues during the implementation of the project.
- Report periodic progress reports to the High Court using the designated proforma, ensuring transparency and accountability.
- Submission of project completion report, including detailed expenditure statements, upon project conclusion using designated proforma.
