According to Technical Evaluation Report,

- i) the Lot No. 3 Colour Printer, both the qualified bidders have offered the items according to required specification. M/s. GEMCO has quoted a multipurpose colour printer, However, consumable items of the quoted printer are not readily available in the local market. It is, therefore, suggested by the Technical Committee to allocate the LOT No. 03 to the second lowest bidder. As per terms and conditions (at Serial No. 13) of the bid soliciting document, it is mandatory qualifications that the bidder will ensure that the consumable parts/items are easily available in the local market.
- ii) the Lot No. 4, both the qualified bidders have offered items in accordance with the required specification. However, the HP Pro-Book 450 G10 quoted by the M/s. GEMCO offers better performance and longer battery life as compared to the Dell Vostro 3530 quoted by M/s. Micro Media. It is, therefore, suggested to accept the offer of the M/s. GEMCO, Islamabad. A slight difference of rate i.e. Rs.2480/laptop can be ignored in order to procure most advantageous item.
- the Lot No. 8, the lowest bidder have offered three options a) Samsung 65" DU7000
 TCL 65" P635 and c) EcoStar 65" QD970, the Technical Committee has recommended that EcoStar should not be considered due to its poor market reputation.
