Press Release

Upon assuming the office as Acting Chief Justice of the Islamabad High Court on 12.02.2025, Hon'ble Mr. Justice Sardar Muhammad Sarfraz Dogar, driven by a strong resolve to address systemic delays, mounting pendency, and lack of case sensitivity in judicial handling, initiated a series of well-conceived, decisive, and impactful administrative reforms. These measures were aimed at achieving timely, effective, and meaningful disposal of cases, thereby restoring and strengthening public trust—the true stakeholder and beneficiary of the judicial system.

2. At the time of taking oath, the total pendency before the High Court stood at 17,756 cases. As of 30.09.2025, the pendency has been successfully brought down to 14,590 cases, despite a fresh institution of 7,735 cases during this period. This downward trajectory clearly reflects that the pendency curve has been reversed, moving closer to the ideal of a responsive and efficient judicial system.

The administrative initiatives undertaken covered the entire spectrum of case management, in line with the policy directions of the National Judicial (Policy Making) Committee (NJPMC). Key measures include:

- Constitution of specialized time-bound benches to hear matters pertaining to overseas Pakistanis, senior citizens, persons of unsound mind, and pauper litigants, ensuring that such sensitive cases are attended to promptly.
- Same-day fixation of Habeas Corpus petitions, guaranteeing urgent judicial response in matters involving personal liberty.
- Regular listing and expeditious hearing of family, rent, and police cases, ensuring that
 no case in these categories remains unattended without a fixed date.
- Formation of subject-specific benches dealing with education, revenue, tax, commercial, and environmental matters, which has significantly optimized disposal rates across specialized domains.
- 3. Particular emphasis was placed on tax matters, which at the national level have long been a source of concern due to judicial delays affecting revenue collection and circulation. To address this, two dedicated Division Benches were periodically constituted exclusively to hear and decide pending tax references. This targeted measure has resulted in a substantial reduction in pending tax cases, thereby facilitating the early release of revenue tied up in litigation and contributing positively to the fiscal stream.
- 4. Through these strategic and well-coordinated administrative interventions, the Hon'ble Chief Justice has set a clear precedent of proactive judicial leadership, demonstrating that focused administrative reforms can yield tangible and measurable results within a relatively short span of time.
